

CONVERSION CERTIFICATE

Act, 1955 as amended from time to time subject to the following conditions.

(a) The conversion/change of character of the land in question will take effect from the date of order/with retrospective effect from 1421 B.S.

(b) The rent of the land in question is fixed at Rs. 15/-(Rupees fifteen) only per decimal as per existing norms and the same is payable from the date on which the conversion/change of character takes effect subject to future adjustments against revenue as may be determined under the provisions of the WBLR Act, 1955 as may be amended from time to time together with any cesses as applicable. He will obtain the no objection certificate / approval / permission/ license/ registration/ pollution clearance as and where required from the competent authority in this regard as per relevant laws, failing which the conversion order shall automatically stand cancelled.

(c.) The applicant/raiyat will relinquish the subject land to the Govt. if it is subsequently vested to the State under the provision of any law in force.
